Despite this sale, Mr Tuddenham has been a buyer of CPT Global shares over the last 12 months having increased his holding by 1,428,321 shares prior to this sale.

Mr Tuddenham has informed CPT Global that the shares he is the beneficial owner of will participate 100% in the dividend reinvestment plan for the dividend declared on 19 February 2021.
